1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Outside areas and boundaries

The property appears to occupy a roughly rectangular shaped site with there being surrounding areas of garden ground. To the front of the dwelling, there is an area of timber decking/ramp which also extends across the adjoining properties. To the rear there is also an area of timber decking. There are some grassed areas to the rear of the site, whilst there is a gravel surfaced driveway to the side providing off-road car parking space. The boundaries where present are formed in post and wire fencing, although we would note that part of the site appears to be unbounded and would recommend that the full extent of grounds pertaining to the property be confirmed by reference to the title.

The ceilings are plasterboard lined.

Internal walls are plasterboard lined.

Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

Floors including sub floors

The flooring is of suspended timber construction, assumed to comprise chipboard sheeting on suspended timber joists, although we would, however, emphasise that our inspection of floor surface areas was restricted due to the presence of fitted floor coverings and furnishings.

There was no access gained to any sub-floor areas.

Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.

Water, plumbing, bathroom fittings

Mains supply. The visible plumbing installation is in copper and plastic pipework where seen.

The sanitary fittings within the Shower Room comprise a three piece suite with there being a WC, wash hand basin and mixer shower intray.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Heating and hot water

Fixed heating is provided primarily by the stove within the Living Room area which also appears to be linked to a radiator. Additional heating is provided by an electric radiator within the Shower Room. Domestic hot water is provided by an electric immersion heater and contained within a pre-insulated hot water cylinder which is within a cupboard off the Inner Hall.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

Drainage

Main sewer.

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

Fire, smoke and burglar alarms

There appears to be a compliant smoke and heat alarm system within the property.

Visually inspected.

No tests whatsoever were carried out to the system or appliances.

New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

Additional limits to inspection

At the date of inspection, the property was furnished whilst the floors were covered.

There was no access gained to any sub-floor areas.


Not all windows and doors were tested during the course of our inspection.

There was no access gained to any roof void areas.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

4. Valuation and conveyance issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

Matters for a solicitor or licensed conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

We would recommend that the full extent of grounds pertaining to the property be ascertained by reference to the title.

We understand that the title to the property has a Rural Housing Burden attached to it. We have been informed that whilst the purchaser will have full title to the property, the sale price is discounted. This then enables the Highland Small Communities Housing Trust to have a right of pre-emption which gives them the first option to purchase the property back at the previously agreed percentage. The purchasers should also be aware that there are other conditions attached to the property including the requirement that they must use the property as their own and sole residence.

Estimated reinstatement cost for insurance purposes

£200,000

We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £200,000 (TWO HUNDRED THOUSAND POUNDS STERLING).

The guidance figure is the estimate of costs for reinstating the subjects as at the date if inspection based on information provided by the Building Cost Information Service (BCIS). Building costs are currently increasing significantly above inflation due to increased demand and supply issues as a result of Brexit and the pandemic. It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover.

Valuation and market comments

£175,000

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £175,000 (ONE HUNDRED AND SEVENTY FIVE THOUSAND POUNDS STERLING).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

The property will be purchased on the basis of a Rural Housing Burden arrangement and the valuation herewith represents the full value of the 100% interest. Consequently any subsequent valuation figure reported to the lender for mortgage purposes may be less depending on that particular lending/reporting criteria.

GENERAL

1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

The Seller will be entitled to cancel the inspection by notifying the Surveyor's office at any time before the day of the inspection.

The Surveyor will be entitled not to proceed with the inspection (and will so report promptly to the Seller) if after arriving at the Property, the Surveyor concludes that it is of a type of construction of which the Surveyor has insufficient specialist knowledge to be able to provide the inspection satisfactorily. The Surveyor will also be entitled not to proceed if after arriving at the Property, the Surveyor concludes that the Property is exempt under Part 3 of The Housing (Scotland) Act 2006 as detailed in the (Prescribed Documents) Regulations 2008. 



'Assumed' means that the insulation could not be inspected and an assumption has been made in the methodology, based on age and type of construction.

The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO₂ emissions, running costs and the savings possible from making improvements.

The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 56 kg CO₂/m²/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 3.8 tonnes of carbon dioxide every year. Adopting recommendations in this report can reduce emissions and protect the environment. If you were to install all of these recommendations this could reduce emissions by 1.2 tonnes per year. 1 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). 2 Solar photovoltaic (PV) panels
